 - Presented to Council on June 14, 2017
- Phase II Preliminary Engineering
 - Current phase
 - Consideration of PSA with domusstudio for preliminary engineering design

Preliminary Engineering

- Needs Assessment Study concluded that a MSC of approximately 3,700 sf to 4,700 sf would satisfy operational needs of Marine Safety Department
- At June 14 meeting, Council directed Staff to reduce the footprint of the new building as much as possible without negatively impacting the operational needs of the Department

Request for Qualifications & Proposals

- Submittals received included qualifications (similar work experience in a marine/ coastal environment)
- Scope of Work included:
 - Size of building limited to 4,000 square feet
 - Preliminary design drawings and other documents that illustrate the scale, relationship, form, size and appearance of the facility components
 - Preliminary landscaping, grading, drainage and stormwater plans

Request for Qualifications & Proposals

- Scope of Work (cont):
 - Geotechnical investigations
 - Preliminary cost estimate
 - Attendance at meetings including View Assessment, Council meetings and a community workshop
 - Permit application for Structure Development Permit/Development Review Permit (SDP/DRP) from the City and a Coastal Development Permit from the California Coastal Commission
